

INFORMATION ON THE PROCESSING OF PERSONAL DATA
pursuant to articles 13 and 14 of Regulation (EU) 2016/679

ASSOCIAZIONE CENTRALE SCUOLA SCI & SNOWBOARD LIVIGNO (here in after also "the Company" or "the Owner") with registered office in Via Plan n. 273 - 23041 Livigno (SO), Tax Code 92001520144, as **Data Controller**, hereby wishes to provide information regarding the processing of personal data supplied for the request for information, booking or to use the relative services, pursuant to of articles 13 and 14 of the EU Regulation 2016/679.

1. TYPE OF DATA PROCESSED

1.1. The Company is the data controller of the personal data communicated by the User and includes:

- surname and name, date of arrival and departure, sex, date of birth; birth place; type, number and place of issue of a document; email address; telephone number;
- company name or company name, fiscal code and other identification numbers, bank details, credit card number, address, e-mail address and Pec;
- photographs and video recordings

1.2. The data could come from travel agencies or local tourist operators affiliated with our association.

2. PURPOSE AND LEGAL BASIS OF THE PROCESSING

The data processing is carried out by the Data Controller in the course of its activities. In particular, the data provided by the Data Subjects will be processed, using IT and non-IT tools, for the following purposes:

- a)** management of reservations, requests for information, provision of the services requested. The legal basis of the processing is represented by the necessity of the treatment for the execution of a contract of which the interested party is a party or the execution of pre-contractual measures adopted at the request of the same (art. 6, paragraph 1, lett. B) EU Reg. 2016/679). For any data processed for the sole purpose of facilitating people with disabilities, the legal basis of the treatment is represented by the free consent expressed by the interested party or, if less, by the parent (Article 9, paragraph 2, letter a) Reg. EU 2016/679);
- b)** fulfillment of tax and accounting obligations. The legal basis of the processing is represented by the need for processing to fulfill a legal obligation to which the Data Controller is subject (Article 6, paragraph 1, letter c) of the EU Regulation 2016/679);
- c)** direct marketing promotional activities with the sending of advertising material and / or newsletters with the aim of building customer loyalty and promoting the products and services offered. The legal basis of the processing is the legitimate interest of the Owner identified in direct marketing (Article 6, paragraph 1, letter f) of EU Regulation 2016/679);
- d)** the defense of a right or interest before any competent authority or entity, expressly included therein for the purposes of credit recovery. The legal basis of the processing is the pursuit of a legitimate interest of the Data Controller consisting in the protection of the company in relation to the contractual relationship with the customers (Article 6, paragraph 1, letter f) of EU Regulation 2016/679);
- e)** taking photographs and / or making video recordings for delivery to the interested parties as a reminder or for publishing them on the website or posting them on company social networks for promotional or illustrative purposes. The legal basis of the processing is the free consent expressed by the interested party or, if less, by the parent (Article 6, paragraph 1, letter a) of the EU Regulation 2016/679).

3. PROCESSING METHODS AND MANDATORY OR OPTIONAL NATURE OF DATA COMMUNICATION

3.1. The Data will be processed by the Company using electronic and manual systems in accordance with the principles of correctness, loyalty and transparency established by the applicable legislation on the protection of personal data and protecting the privacy of the Interested Person through technical and organizational security measures to guarantee a level of adequate security.

3.2. The provision of data for the purposes identified in point a) and b) is to be considered mandatory to the extent that failure to provide it makes it impossible for the Company to reply to requests for information or reservations, as well as to provide the services requested. The data provided for the purposes identified in point c) is to be considered optional and a condition for receiving communications. In case of refusal to consent to the processing of data according to the methods described in the purposes referred to in letter c) "marketing", in the absence of automated systems for requesting cancellation, he may request or request the Data Controller by e-mail to the address info@scuolascicentrale.it

The provision of data for the purposes referred to in point e) is optional and subject to prior consent, in the absence of which it will not be possible to take photographs or make video recordings, including the delivery of the material to the interested party and any form of publication.

3.3. The provision of data for the purposes referred to in point e) is optional and subject to prior consent, in the absence of which it will not be possible to take photographs or make video recordings, including delivery of the material to the interested party and any form of publication.

4. DATA RETENTION

The personal data processed for the purposes referred to in points a) and d) will be kept for the time strictly necessary to achieve those same purposes. In any case, since these are treatments carried out for the provision of services and for any subsequent contractual protection, the Data Controller will process the data up to the time allowed by the Italian legislation for the protection of their interests or for the period of prescription of the rights that can be exercised by the Owner (articles 2946 and following of the civil code, except for disputes. The personal data processed for the purposes referred to in point b) will be stored in relation to the conservation obligations provided for by the specific regulations provided for by the law.

The personal data processed for the purposes referred to in point c) and e) will be kept until revocation or cancellation request

by the interested party.

5. RECIPIENTS OR ANY CATEGORIES OF RECIPIENTS OF PERSONAL DATA

The data will be processed, within the limits of what is necessary, by authorized personnel, including the staff assigned to the secretariat and the individual associated masters, adequately educated and trained, of the Data Controller as well as by the personnel of the third parties Autonomous Owners who provide services to the Owner and they process data on behalf of and on the instruction of the latter as data processors. Furthermore, for the purposes indicated above, the data may be disclosed to:

- consultants and freelancers in a single or associated form, service companies, trade associations that provide the Company with assistance or advice for financial, administrative, accounting, tax and legal protection purposes;
- companies, organizations, persons who provide assistance in the field of marketing and communication regarding the provision of services;
- insurance companies and credit institutions;
- associations of local authorities;
- subjects, Entities or Authorities to which it is obligatory to communicate their personal data by virtue of provisions of law or orders of the Authorities;
- technicians and IT companies responsible for managing and maintaining the website and the IT network of the Data Controller and any cloud providers and management software for requesting reservations, checking availability, confirming and paying for services.
- companies or professionals for printing photographs and developing video recordings.

The list of possible joint owners and data processors is available at the owner's offices.

6. DATA TRANSFER

The data controller does not transfer personal data to third countries even if he reserves the right to use cloud services and in this case the service providers will be selected from among those who provide adequate guarantees, as required by art. 46 EU Reg. 2016/679.

7. RIGHTS OF THE INTERESTED PARTY AND METHODS OF EXERCISE

The interested party may exercise, in relation to the processing of the data described therein, the rights provided by the EU Regulation 2016/679 (articles 15-21), including therein: receiving confirmation of the existence of the data and accessing their content (access rights); update, modify and / or correct the data (right of correction); request the deletion or limitation of the processing of data processed in violation of the law, including those whose storage is not necessary in relation to the purposes for which the data was collected or otherwise processed (right to be forgotten and the right to limitation); oppose the processing (right of opposition); in cases where the processing is based on your consent, the possibility to revoke the consent at any time without this compromising the lawfulness of the processing before the revocation (right to revoke the consent); to lodge a complaint with the Supervisory Authority (Garantor for the protection of personal data www.garanteprivacy.it) in the event of violation of the rules on personal data protection; receive an electronic copy of the data concerning him as an Interested Party, when such facts have been returned in the context of the contract and request that such data be transmitted to another data controller (right to data portability).
